CMS is developing online training for federal nursing home regulatory areas that will be available to the public on the CMS website in 2017. MDH understands this will be available by the fall, 2017. **Examples of possible areas may include:** quality of care/quality of life; abuse/neglect; infection control; person centered care; behavioral health; psychotropic medications & unnecessary medications; transfer/discharge; sufficient staff; facility assessment; and QAPI.
