

Background of IMPLICIT network

- IMPLICIT is an acronym:
 - Innovations for Maternal and Perinatal Care and Improvement Grant
- Formerly Interventions to Minimize Preterm and Low birth weight Infants using Continuous Quality Improvement Techniques
- The IMPLICIT Network was established in 2003 and today includes 27 sites
- 22 sites have implemented ICC and 19 are sharing data with the network



Interconception care

- Model implemented by the IMPLICIT Network
- "Care provided to [birthing parents] between pregnancies to improve health outcomes for [birthing parents], newborns, and children" Rosener, S. E., et al, 2016.
- Focuses on accessing birthing parents through their child's well child visits
- Interconcpetion care promotes healthy outcomes in future pregnancies.

Clinical screening and intervention


- ICC uses brief screening for birthing parents during well-child visits from 0-24 months of age
- A participating clinic will:
 - Assess current risk factors at each visit
 - Screening vs Intervention
 - Reinforce desired behaviors
 - Refer/connect with providers and community resources to address identified risks
 - Collect and analyze data

IMPLICIT in Minnesota

- Identified by MN in 2020 as an evidence-based method for birth defects prevention and promotion of future healthy pregnancies
- Funded by state birth defects dollars
- 5-year RFP was posted in January 2020, current grant cycle is coming to an end
- Next grant cycle will be for 3 years

IMPLICIT grant structure in MN

- Grantee acts as an intermediary between MDH, National IMPLICIT Network, and clinics
- Grantee recruits participating clinics
- Grantee enters participating clinics into an agreement
- Grantee trains and assists in the implementation of the ICC model in clinical settings



MDH grant structure in MN* cont.

- Other grantee responsibilities:
 - Technical assistance and training
 - IMPLICIT Network membership and networking
 - Evaluation
 - Administration of clinic stipends

*eligible projects **must** contain all key tasks and deliverables

The ideal clinic perspective

- Providing primary care, family medicine, or pediatric care
- Working collaboratively with MDH, grantee, and the IMPLICIT Network
- Receiving technical assistance and connection to other IMPLICIT participants
- Receiving compensation for participation

RFP Details

CORRECTION

- There will be a correction to the RFP coming this week about clinic stipends
- Clinics must receive NO LESS than \$12,000 and NO MORE than \$18,000 in stipend for participating in the first year
- The remaining budget will pay for the remaining budgetary needs of the grant, including travel to the annual IMPLICIT meeting and travel to clinics

Eligible applicants*

- Individuals,
- not-for-profit organizations,
- for-profit organizations, and
- health centers with clinical quality improvement experience are eligible to apply.

*Applicants may apply from out-of-state, but are encouraged to review the due diligence form prior to creating their proposal

Number of awards and funding

- 1 grantee will be selected to administer the subgrants
- \$130,000 per year, with a pro-rated amount for the shorter first year in the grant cycle


