

## School Reporting of Vaccine-Preventable Diseases

The following table lists the reporting requirements for vaccine preventable diseases (VPDs) that are commonly seen in schools. <b>Chickenpox</b> (varicella) <b>Mumps</b> <b>Pertussis</b> (whooping cough) <b>Shingles</b> (zoster)	<p><b>Chickenpox, Mumps, Pertussis:</b> All suspected and confirmed cases in students and/or staff.</p> <p><b>Shingles:</b> Suspected or confirmed cases of shingles in students only.</p>	<p><b>Report all cases within one working day.</b></p> <p>Note: If you suspect the onset of an outbreak of chickenpox (3 or more cases) or pertussis (2 or more cases in 42 days), promptly contact MDH via phone.</p>	<p>Submit reports using the <a href="https://redcap.health.state.mn.us/redcap/surveys/?s=WTLE8NA7FYFFCE8">Vaccine Preventable Disease (VPD) Reporting Form (https://redcap.health.state.mn.us/redcap/surveys/?s=WTLE8NA7FYFFCE8)</a>.</p> <p>To request test kits for chickenpox or pediatric zoster, complete the <a href="https://redcap.health.state.mn.us/redcap/surveys/?s=JLLNAWXPXHHFWMNX">VPD Test Kit Requests (https://redcap.health.state.mn.us/redcap/surveys/?s=JLLNAWXPXHHFWMNX)</a>.</p> <p>Test kits for pertussis and measles are also available for local public health and health care facilities.</p> <p>Contact 651-201-5414 or 1-877-676-5414 with questions about reporting.</p>
<b>COVID-19</b> (SARS-CoV-2) <b>Influenza–like illness (ILI)</b> <i>ILI is defined as a fever and cough and/or sore throat.</i>	<p>When 10% of total student enrollment is absent with respiratory illness in a single day.</p>	<p><b>Report when 10% of total student enrollment is absent with respiratory illness in a single day.</b></p> <p>A follow-up survey will be sent in seven days for you to provide updates on the status of the outbreak.</p> <p>You do not need to submit additional respiratory illness outbreak reports for 14 days.</p> <p>You do not need to report individual flu cases.</p>	<p>Submit reports for each school using the <a href="https://redcap.health.state.mn.us/redcap/surveys/?s=MJEJYFFCKNLD4N4C">Respiratory Illness and Gastrointestinal Illness Outbreak Reporting Form (https://redcap.health.state.mn.us/redcap/surveys/?s=MJEJYFFCKNLD4N4C)</a> when 10% student threshold is met.</p> <p>Contact <a href="mailto:health.schools.covid19@state.mn.us">health.schools.covid19@state.mn.us</a> with questions about reporting COVID-19.</p>
