Cov ntawv pov thawj uas pom zoo txais

- Ib tsab ntawv tseem lossis hauv electronic los ntawm lub koom haum uas txhaj tshuaj rau koj. Tej ntaub ntawv xws li MyChart lossis ntawv uas qhov chaw txhaj tshuaj ntawd muab tes sau los kuj tau thiab.
- Ib daim npav tseem uas yog daim txhaj tshuaj rau COVID-19 los ntawm CDC.
- Daim ntawv U.S. Department of State's Vaccination Documentation form DS-3025 uas qhia txog nws tej kev txhaj tshuaj yav tag los.
- Daim npav txhaj tshuaj International Certificate of Vaccination or Prophylaxis (yog ib daim ntawv daj).
