


# 2015-16 Annual Immunization Status Report (AISR) Summary

## 2015-16 School Immunization Percentages


For the 2015-16 school year, 67,262 of 69,193 (97.7 percent) kindergarteners and 69,014 of 69,319 (99.6 percent) seventh graders had immunization data reported in the AISR. The kindergarten and seventh grade enrollment totals are from the Minnesota Department of Education (MDE). The enrollment totals from MDE do not include home school children and private schools that did not report enrollment data to MDE for the 2015-16 school year.

## **Immunization Percentages: Kindergarten and Seventh Grade**


#### Percent of Kindergarteners Vaccinated, 2015-16




#### Percent of Seventh Graders Vaccinated, 2015-16

<sup>&</sup>lt;sup>b</sup> The fourth dose of polio vaccine is not required if the third dose was given after the fourth birthday

<sup>&</sup>lt;sup>c</sup> Most students will have more than 3 doses, but those who missed out on all or part of their childhood immunizations can meet the requirement by adhering to the catchup schedule, which calls for a total of 3 doses (4 if the first dose was given before the first birthday).

<sup>&</sup>lt;sup>d</sup> Three doses is the minimum required for children 7 years of age or older, regardless of the age when the initial series was given

<sup>&</sup>lt;sup>e</sup> A two-dose hepatitis B adolescent schedule given between the ages of 11 through 15 years is acceptable
