Tus muaj ntawv pov thawj los ua tus thawj tswj tiv thaix zaub mov (certified food protection manager (CFPM)) yuav tsum paub txog, muaj txuj thiab ua tau raws li cov haujlwm sau hauv qab no:

- Paub thiab qhia taw tau txog tej teeb meem muaj tshwm sim rau txhua hnuv uas qhib lab ua zaub mov noj.
- Tsim tsa lossis nqis tes ua raws li tej txhooj cai, txheej txheem lossis ncej txheem uas teev tseg los tiv thaix kom tsis txhob muaj kab mob los ntawm zaub mov.
- Teem sijhawm cob qhia cov neeg ua haujlwm txog kev xyuam xim ntawm zaub mov, tej kev ua zaub mov thiab ua raws li tsim nyog los kho tej yam tsis yog kom thiaj li tiv thaix kev noj qab haus huv rau cov neeg uas yuav khoom noj .
- Txhua hnuv yuav tsum ntsuas lub lab seb puas ua raws li tej txhooj cai thiab txheej txheem xyuam xim rau zaub mov.

Duties

The certified food protection manager (CFPM) must have the knowledge, skills and abilities to complete the following duties:

- Identify hazards in the daily operation of the food establishment.
- Develop or implement policies, procedures or standards to prevent foodborne illness.
- Coordinate employee food safety training, direct food preparation activities and take corrective action as needed, to protect the health of the consumer.
- Complete in-house self-inspections of daily operations to ensure that food safety policies and procedures are followed.

Required training

Approved CFPM training courses for initial and renewal certification are offered by many private companies, community and technical colleges and some delegated

Yog tias koj tsis tau ua ib tug CFPM hauv Minnesota dua los li:

1. Mus kawm ib chav uas tau kev pom zoo thiab xeem kom dhau.
2. Xa daim ntawv tso npe kawm, ib daim ntawv luam koj daim exam certificate nrog rau them tus nqi \$35 xa mus rau MDH, PO Box 64495, St. Paul, MN 55164-0495.

Mus tso npe rau thawj zaug ua ib tug CFPM hauv Minnesota li ntawm 6 hli tom qab koj xeem dhau.

Rov ua ntawv pov thawj tshiab

Daim ntawv CFPM hauv Minnesota yuav tag sijhawm tom qab 3 xyoos rau hnub tim sau rau hauv daim MDH certificate. Yog xav ua daim ntawv pov thawj dua tshiab:

1. Mus kawm ntxiv 4 xaub moos los tshaj rov sau ntawm tej chav kawm uas tau kev pom zoo.
2. Xa daim ntawv tso npe kawm, ib daim ntawv luam koj daim exam certificate nrog rau them tus nqi \$35 xa mus rau

agencies. MDH does not offer training, but does approve trainers and courses.

Initial certification

If you have never been a Minnesota CFPM:

1. Attend a training course and pass an approved exam.
2. Mail initial application, copy of exam certificate and \$35 fee to MDH, PO Box 64495, St. Paul, MN 55164-0495.

Download and print [Initial Application \(PDF\)](#).

Apply for initial Minnesota CFPM no more than six months after passing the exam.

Certification renewal

Minnesota CFPM expires three years from the effective date printed on the MDH certificate. To renew certification:

1. Complete four or more hours of approved training.
2. Mail renewal application, approved training certificate(s) and \$35 fee to MDH, PO Box 64495, St. Paul, MN 55164-0495.

Cov tso npe ua thawj zaug thov daim ntawv pov thawj yuav tsum muaj ntawv pov thawj tias lawv yeej xeeb dhau los ntawm ib lub koom haum uas tau kev pom zoo los ntawm [ANSI-CFP Accreditation Program](#).

Cov lus nquag nug

Tiv tauj lub koom haum uas muab daim lais xees tso cai rau lub lab yog xav paub txog tej cai hauv zos thiab cov txheem lus hauv Minnesota food code seb muaj feem li cas rau hauv koj lub lab.

Kuv puas yuav tsum tau mus ua tus CFPM yog tias kuv yog tus tswv ntawm lub lab mov noj?

Tsis tas ua. Yeej muaj ntau tus tswv ntawm lawv lub lab xav ua tus CFPM, tiam sis tsis tas ua los tau. Ib tug CFPM uas zoo yog ib tug uas paub zoo txog koj lub lag luam thiab muaj cuab kav los nqis tes ua raws li tej haujlwm CFPM hauv koj lub lab.

Yuav tsum muaj pes tsawg tus CFPM nyob hauv ib lub lab ua mov noj?

Take renewal training within the effective dates of the valid certificate. Apply for renewal no more than six months after the expiration date printed on the MDH certificate.

Approved exams

Applicants for initial certification must provide proof they have passed an exam from an organization accredited by the [ANSI-CFP Accreditation Program](#).

Frequently asked questions

Contact the agency that issues the license for the establishment for more information about local ordinances and how the Minnesota food code applies to your establishment.

As the food establishment owner, do I have to be the CFPM?

No. While many food establishment owners decide to be the CFPM for their establishment, it is not required. An effective CFPM has a good working knowledge of your business and has the authority to conduct the CFPM duties in your establishment.

How many CFPMs are required for a food establishment?

Minnesota food code requires each licensed food establishment to employ one CFPM.

Puas kam kuv ua tus CFPM yog tias kuv muaj ntau lub lab ua mov noj?

Tsis pub.

Kuv yuav muaj sij hawm ntev npaum li cas ntiav lossis cob qhia ib tug CFPM tshiab?

Minnesota food code tswj kom txhua lub lab ua mov noj yuav tsum muaj ib tug CFPM tsis dhau 60 hnuv uas nws qhib nws lub lab ua noj. Koj yuav tsum muaj tsawg kawg los ib tug neeg ua haujlwm uas tau xeem dhau lossis tso npe ua ib tug CFPM hauv Minnesota ua ntej koj pib qhib koj lub lab ua noj. Cov cai hauv zos tej zaum yuav muaj lwm yam ntxiv thiab los tau.

Puas muaj tej yam zam tau uas tsis tas muaj tus CFPM?

Muaj, qee hom lab ua noj - nyob ntawm nws hom lais xees ntawv tso cais lossis seb nws npaj ua zaub mov noj li cas - kuj tsis tas muaj ib tug CFPM hauv Minnesota los tau.

Cov lab uas zam tau txoj cai no yog:

- Tej lab ua zaub mov noj uas muaj kev phom sij qis.
- Laub muag khoom noj rau tej koob tsheej
- Ib lub tsheb muag khoom noj, lub tsheb lossis laub uas coj mus rau qhov twg los tau.

Ntxiv thiab, muaj kev zam tau rau tej lab yog tias:

Local jurisdictions may have additional requirements.

Can I be the CFPM for more than one location?

No.

How long do I have to hire or train a new CFPM?

Minnesota food code requires new food establishments to have a CFPM on staff within 60 days of opening. You must have at least one employee who has passed an approved exam or applied for Minnesota CFPM before you begin operating your establishment. Local jurisdictions may have additional requirements.

Are there exemptions from CFPM requirements?

Yes, certain food establishments—based on license type or food preparation activities—are exempt from Minnesota CFPM requirements.

Some exempt establishments may include:

- Low-risk food establishment
- Special event food stand
- Retail food vehicle, portable structure, or cart

In addition, establishments may be exempt if food preparation activities are limited to:

- Preparing or packaging food and ingredients that are not

- Muaj nqaij nyoos, nqaij qaib, nqaij ntses lossis nqaij tsiaj qus uas cov neeg yuav coj mus ua noj tom tsev.

Cov lus qhia txog kev zam tau txoj cai muaj tus CFPM no mus nrhiav nyob rau hauv Minnesota Rules, part 4626.0033, item B.

time/temperature control for safety food (non-TCS food).

- Heating or serving precooked hot dog or sausage products, popcorn, nachos, pretzels, or frozen pizza.
- Processing raw meat, poultry, fish or game animals intended for cooking by the consumer.

A list of exemptions to CFPM requirements is found in Minnesota Rules, part 4626.0033, item B.
