

Summary of Changes to RRP Rule Draft (07/12/23)

4620.6000 GENERAL.

Subpart 1. Applicability.

Item A(3). (Page 1, line 10) Updated internal to "part 4620.6200, subpart 6"

Item A(4). (Page 1, line 12) Updated internal to "part 4620.6200, subpart 6"

4620.6025 DEFINITIONS.

Subp. 2. Affected property. (Page 2, line 21)

Deleted entire text of definition and replaced with:

"A. "Affected property" means any of the following properties constructed before 1978:

(1) a single-family dwelling, including:

(a) attached structures, such as an attached porch, stoop, or garage, regardless of construction date;

(b) detached structures and improvements constructed before 1978;

(2) a dwelling unit in a multiunit housing building, including interior and exterior common areas of:

(a) the multiunit housing building;

(b) attached structures, regardless of construction date;

(c) detached structures and improvements constructed before 1978;

(3) a child-occupied facility in a building or portion of a building, including interior and exterior common areas, that is visited by the same child; and:

(a) the child's combined weekly visits last at least six hours; and

(b) the child's combined annual visits last at least 60 hours.

B. "Affected property" does not include:

(1) housing for the elderly or persons with disabilities, unless at least one child resides or is expected to reside in the residence;

(2) a zero-bedroom residence, unless at least one child resides or is expected to reside in the residence.”

“**Child.** “Child” has the meaning given in Minnesota Statutes, section 144.9501, subdivision 6a.”¹

Deleted “under six years of age” from 1/18/22 draft (lines 4.25; 5.1)

Page 5, line 20. Added “emergencies” after “following”

Page 5, line 23. Deleted “significant equipment or property damage” from 1/18/22 rule draft (line 5.22) and replaced with “significant damage to property”

Subp. 20. **Lead inspector.** (Page 6, line 10)

Deleted entire text of definition from 1/18/22 draft (lines 6.10-6.12) and replaced with:

“**Lead inspector**” means a person licensed under Minnesota Rules, part 4761.2280 to perform lead inspections under Minnesota Rules, part 4671.2560.”

Subp. 22. **Lead risk assessor.** (Page 6, line 16)

Deleted entire text of definition from 1/18/22 draft (lines 6.17-6.20) and replaced with:

“**Lead risk assessor means**” person licensed under Minnesota Rules, part 4761.2300 to perform lead risk assessments under Minnesota Rules, part 4671.2570.”

Child. "Child" means an individual up to 72 months of age.
